Purchases / Contracts

Tree work was undertaken by MJ Tree Services £5675 May 2021 P10. As part of the audit trail and for Electors Rights – include all the quotations received and attach to the payment P10

VAT

VAT was reclaimed for the financial year. Note that a purchase made for the Council in May 2021 (P6) VAT Registration 233112755 could be claimed. This is only a very small amount of money.

Grant Application Form

The Parish Council has a Grant Application form for use of organisations such as the Jubilee Committee (P33 January 2022). Using this form provides an audit trail and as well, assurances on the use of the monies.

Insurances

There appear to be some anomalies between the Asset Register and the list of assets on the Insurance Document provided by BHIB Insurance Brokers. Review your insurance provider when the opportunity arises. Ensure all property is listed and the insurer is informed.
